The trustees present their report with the financial statements of the charity for the year ended 31 December 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The Charity's principal objective is to raise funds from subscriptions, donations, fundraising events and legacies to provide additional equipment and amenities for patients, visitors and staff of the NHS Trusts serving the communities of Brighton & Hove and Newhaven.

In 2021 the NHS Trusts supported were:

- University Hospitals Sussex NHS Foundation Trust from 01.04.2021
- Brighton and Sussex University Hospitals NHS Trust until 31.03.2021
- Sussex Community NHS Foundation Trust
- Sussex Partnership NHS Foundation Trust

During 2021, funding of £167,154 provided support for equipment and services:

Small Acts of Friendship 2 (Respiratory Wards): Year 2: £55,000

Equipment for wards and departments at University Hospitals Sussex NHS Foundation Trust (Royal Sussex County Hospital): £32,903

Equipment for Sussex Community NHS Foundation Trust: £251

Equipment for Sussex Partnership NHS Foundation Trust: £4,000

All the equipment and services funded in 2021 were focussed on improving the patient experience whilst in hospital. We work closely with colleagues in the NHS to ensure everything your Friends fund benefits patients. However, due to the pandemic and the enormous pressures placed on NHS staff directly, we also worked hard to support staff themselves in practical ways.

At the start of 2021 the UK was in the third Covid-19 pandemic national lockdown. Friends of Brighton & Hove Hospitals remained busy and active, responsive to requests for funding for services to benefit patients and front-line staff. Fundraising opportunities were very limited and income generation was a challenge for all charities including the Friends. For many small local charities, the drop in income in 2020 and 2021 will impact future funding decisions.

Our Projects

Small Acts of Friendship

Small Acts of Friendship (SAF) is a unique initiative devised by Elderly Care Consultants at the Royal Sussex County Hospital (RSCH) and supported by Friends of Brighton & Hove Hospitals. The programme is designed to keep older patients socially active and help retain mobility and well-being whilst in hospital and better able to re-join their community when they leave. The programme was identified as an example of outstanding practice in a Care Quality Commission (CQC) report.

SAF Co-Ordinator Paola O'Sullivan manages a mixed team of volunteers, therapists and activity facilitators offering treatments and therapies such as hairdressing, Indian head massage and reflexology amongst other activities. At the start of 2021, with no volunteers or therapists able to attend the wards, Paola continued vital patient engagement ensuring the Small Acts ethos remained embedded during an extremely difficult time for clinical staff. During the year restrictions eased and Paola welcomed back volunteers, therapists and activity facilitators to the elderly care wards. Funding of £30,000 for SAF Year 5 (2021 - 2022) was confirmed.

In January 2021, Trustees agreed to extend the Small Acts of Friendship model of patient engagement and support to the Acute Respiratory Unit. Respiratory Consultant Katherine Hurt and her team are the clinical leads. Funding of up to £100,000 was confirmed (£45,000 Year 1 and £55,000 Year 2).

Trustees acknowledge and thank SAF Co-Ordinator Paola O'Sullivan for her continued and valued work in managing the SAF project and adapting patient services during a challenging year, for the continued benefit of patients.

Professor Michael Whiting 1946 - 2021

In January former Friends Chairman Professor Michael Whiting passed away after a short illness. Michael was known to many as Chairman of Brighton Health Care NHS Trust (2001 - 2003) and Founding Chairman of BSUH NHS Trust (2001 - 2003).

After retirement as Professor Emeritus from the University of Brighton, Michael became Chairman at Friends of Brighton & Hove Hospitals (2007 - 2012) where he is remembered as a vibrant, hands-on Chairman with an excellent relationship with NHS colleagues across the city.

Michael was a much-loved husband, father and grandfather.

The **Annual General Meeting** was held at the Hove Club 20th July 2021. A welcome opportunity to meet up in person with Patrons, members and supporters. Trustees gave a presentation focussing on Small Acts of Friendship.

The **Friends Café** at the Park Centre for Breast Care is run and managed by volunteers, supported by the Friends Office. The Café re-opened with reduced hours in April 2021 after the third Covid lockdown. Four volunteers returned and the Café now opens 9.30am - 1.30pm four days a week. The service is valued by patients and staff at the centre, but many departments based in the building continued home working for the majority of 2021 hence the volume of business decreased. Despite a highly disruptive year the net proceeds were £4,560.

Trustees accepted Glynn's resignation at the meeting and noted his enthusiasm, dedication and commitment to the Friends during his time as Chairman.

Vice-Chair Chris Rendel was unanimously elected Chairman to succeed Glynn Jones from 1st April 2022.

FINANCIAL REVIEW

Financial position

The charity incurred a deficit during the year of £74,624 on unrestricted funds and this has been deducted from the reserves brought forward to leave reserves to be carried forward of £235,132.

Reserves policy

It is the policy of the Charity to maintain unrestricted and unallocated funds, which are the free reserves of the Charity, at a level sufficient to cover future unrestricted expenditure. This provides funds to cover management and administration costs and to respond to applications for grants that arise.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Friends of Brighton & Hove Hospitals is governed by a document first issued in 1949. The charity was registered with the Charity Commission for England and Wales on 22 September 1962.

In 2004 the charity title was changed from League of Hospital and Community Friends, Brighton, Hove and Newhaven to Friends of Brighton & Hove Hospitals.

In 2015 and 2019 changes were made to the rules on Trustee terms of office, membership, numbers required for a quorate General Meeting and to allow electronic communications.

Appointment of new Trustees

The constitution states there should be a maximum of fifteen members in total all of whom are elected (and for longer standing members, re-elected) at the Annual General Meeting.

New members may attend Committee meetings before being elected. Friends of Brighton & Hove Hospitals have a policy for the recruitment, selection and induction of members which is checked and approved by the Trustees every year. The Charity Commission leaflet CC3(A) is circulated to all new members.

The Friends have established a register of pecuniary interests and attendance at meetings and events is monitored.

Organisational structure

The Trustees are responsible for the management of the charity and will report on the year's work at the Annual General Meeting.

Further details are contained in the chairman's report.

Risk management

The trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').







NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 DECEMBER 2021

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS102, have been prepared in accordance with the Charities SORP (FRS102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019)', Financial Reporting Standard FRS102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act. The financial statements have been prepared under the historical cost convention.

The accounts are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The Trustees consider there are no material uncertainties about the charity's ability to continue as a going concern. Income from fundraising activities has reduced due to the Covid-19 pandemic and therefore steps taken to make cost savings. Trustees regard any impact to be short term rather than affecting the charity's ability to operate in the foreseeable future. There are no material uncertainties affecting the current year's accounts.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Income from donations is accounted for as received by the charity. The income from fundraising ventures is shown gross, with the associated costs included in fundraising costs. The value of voluntary work is not included in the financial statements.

For legacies, entitlement is taken on a case by case basis as the earlier of the date on which: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. If the legacy is in the form of an asset other than cash or an asset listed on a recognised stock exchange, recognition is subject to the value of the asset being able to be reliably measured and title to the asset has passed to the charity. Where legacies have been notified to the charity or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Grants payable

Grants payable are included in the accounts when the obligation to make the payment arises. Any grants awarded, but unspent within two years are written back to be made available for future funding bids.

Allocation and apportionment of costs

Staff costs have been allocated between grant making and other charitable activities according to the time spent by staff on each activity.

Other support costs attributable to each activity have been allocated on a direct cost basis or, for other overhead costs, apportioned according to management estimates.

Expenditure

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Tangible fixed assets

Fixed assets are depreciated so as to write off their cost over their useful economic lives at the following rates :

Office equipment - 15% straight line basis.

Tangible Fixed Assets costing more than £1,000 are capitalised and including any incidental expenses of acquisition.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charity operates a defined contribution pension scheme. Contributions payable to the charity's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Donated goods

Donated goods and services have not been recognised in these financial statements as it is not practicable to do so and the cost outweighs the benefit.
